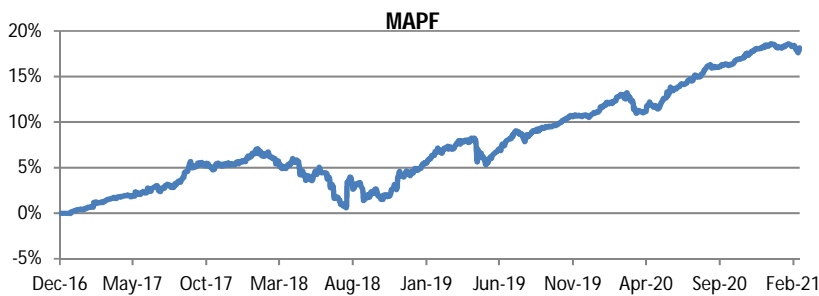
Investment Objectives

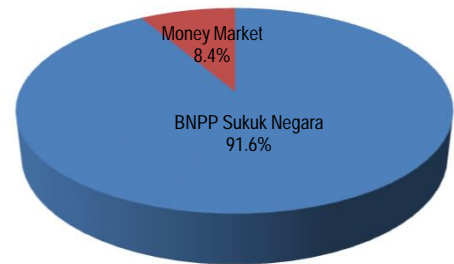
