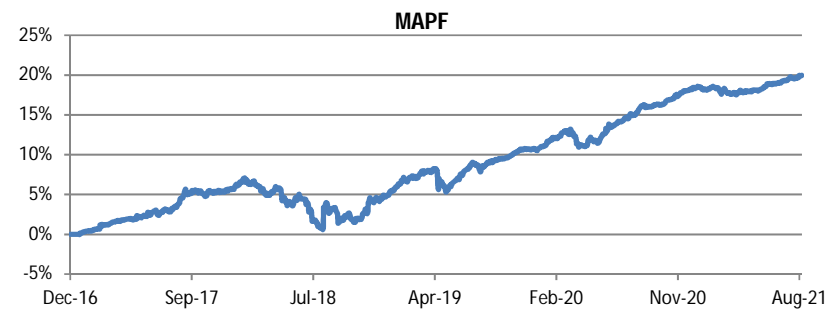
Investment Objectives

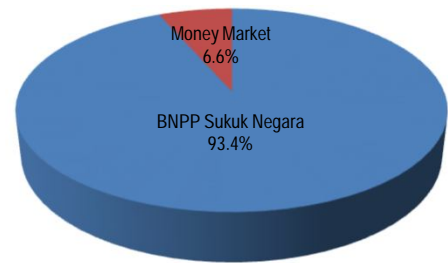
