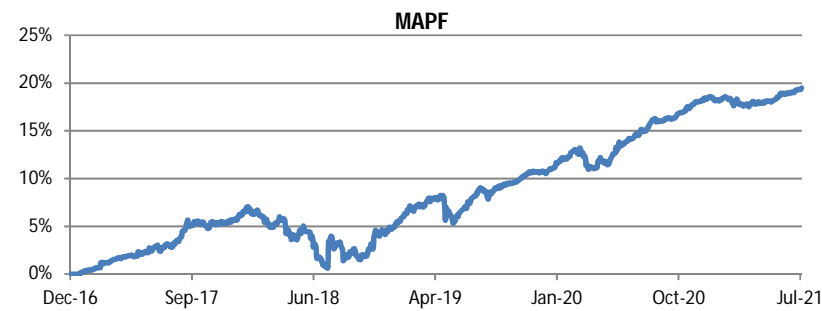
Investment Objectives

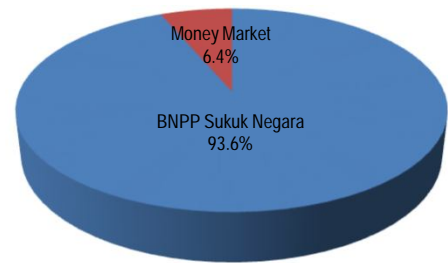
