

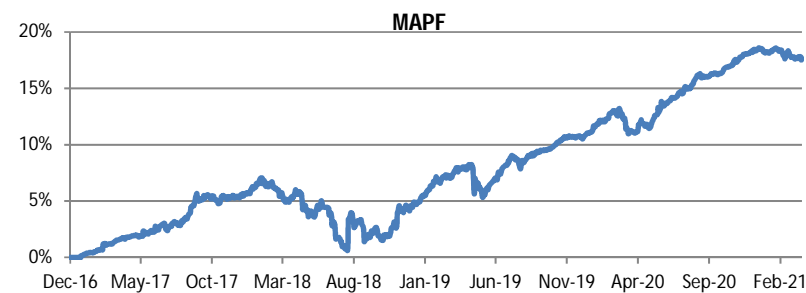
Investment Objectives

Since Inception Performance



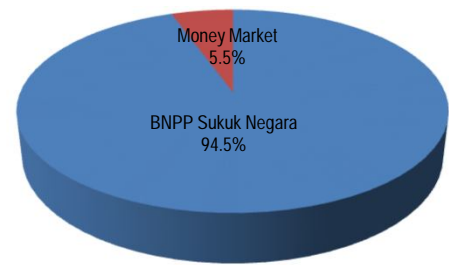
