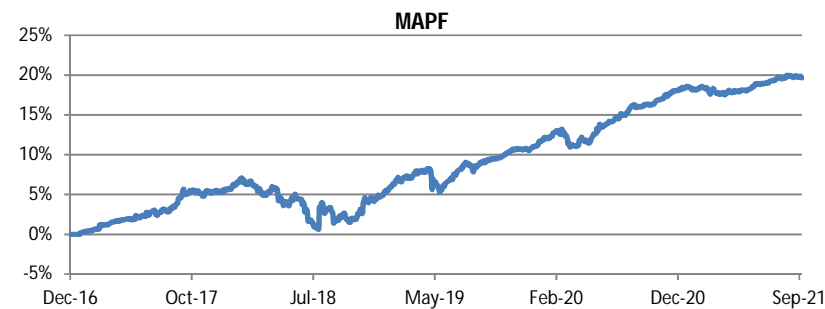
Investment Objectives

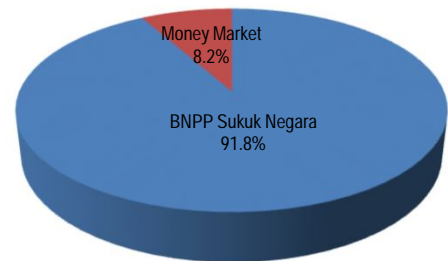
