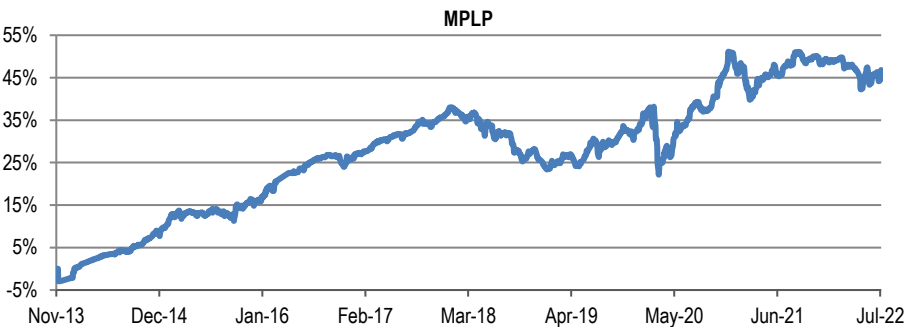

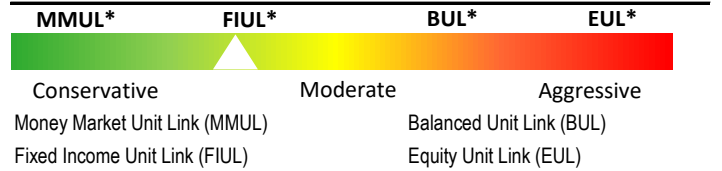
Since Inception Performance

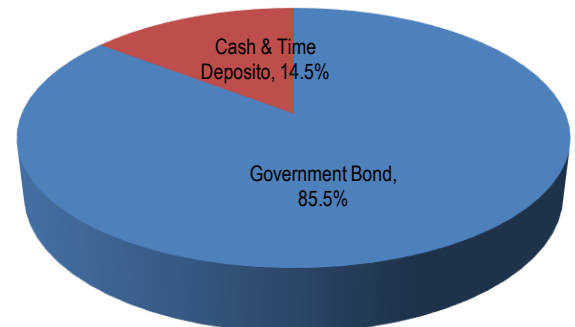
