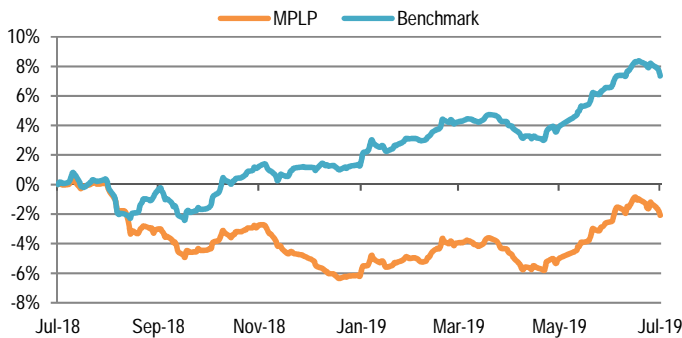

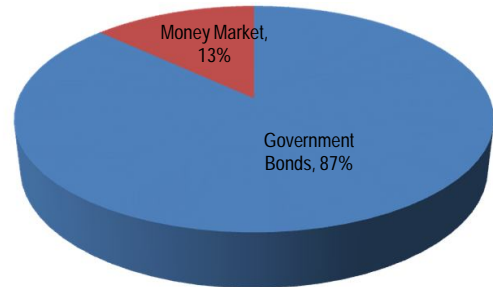

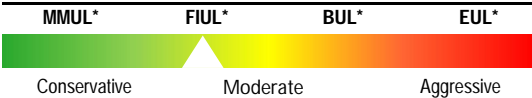
1 Year Performance
