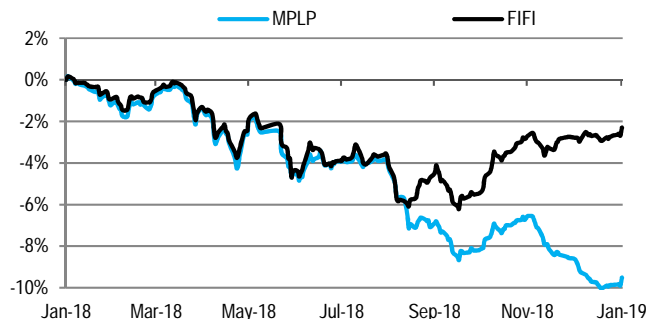

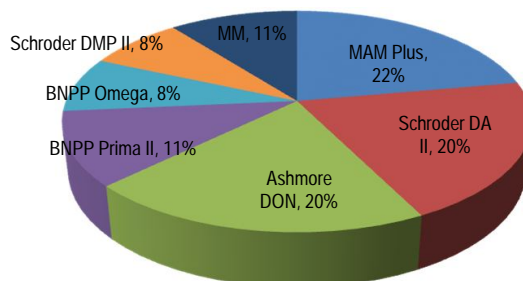

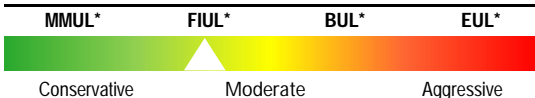
**1 Year Performance**
