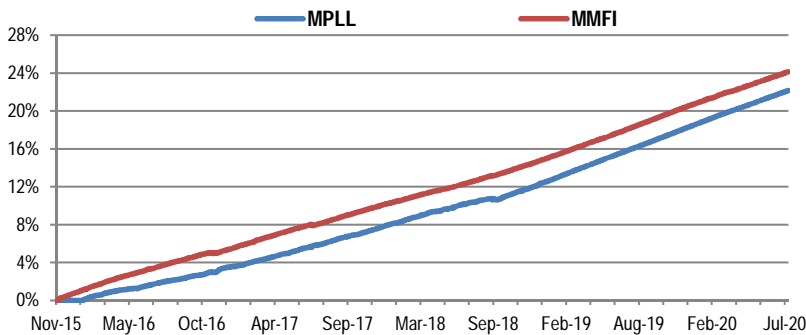

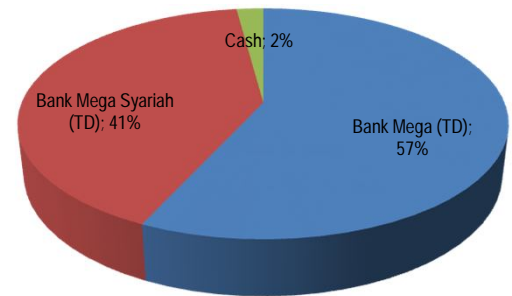

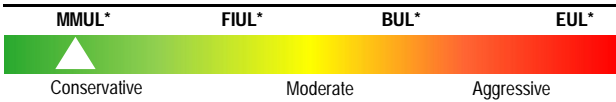
**Since Inception Performance**
