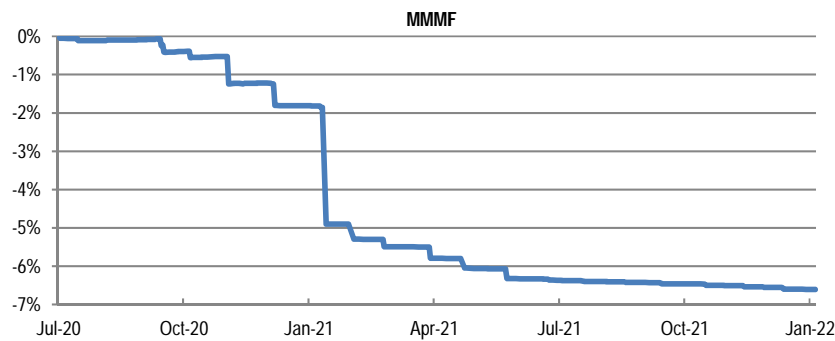

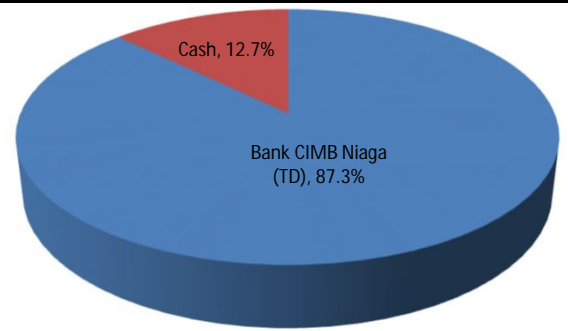

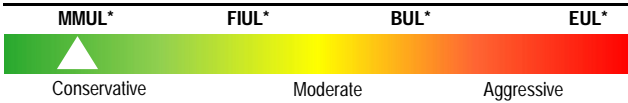
Since Inception Performance
